Permit Conditions:

- *MFV*'s are limited to locations that have a Town of Lake Lure zoning permit for the use of Mobile Food Vendors. *MFV* vehicle shall be set up outside of zoning setbacks.
- The *MFV* shall have the signed approval of the property owner for any location at which the *MFV* operates and that written approval must be available for viewing by Town officials when *MFV* is operating on that location. Failure to meet this requirement may result in an order to close the business operations until such time approval is provided.

(eff: 1/23/23)

- Hours of operation for *MFV*'s shall be limited to 7a.m. to 11p.m.
- The *MFV* must provide confirmation of compliance with all applicable health regulations.
- The *MFV* vehicle shall be positioned at least 100 feet from the customer entrance of an existing restaurant during its hours of operation, unless the *MFV* operator provides documentation from the restaurant owner supporting a closer proximity.
- The *MFV* vehicle shall not block aisles, access to loading/service areas, or emergency access and fire lanes. The *MFV* vehicle shall be positioned at least 15' from fire hydrants, any fire department connection, driveway entrances, alleys, or handicapped parking spaces and must have at least three dedicated off-street parking spaces (in addition to spaces required by Section 36-218, Zoning, for any other existing uses on parcel).
- *MFV* shall provide adequate trash receptacle(s) for customers and remove trash from property each day. (Town trash receptacles do not satisfy this requirement.) All associated equipment, including trash receptacles, must be within five (5) feet of the *MFV* vehicle.
- No liquid, grease or solid wastes shall be discharged from *MFV*. All wastes and/or trash must be disposed of appropriately.
- *MFV* must have the functional fire extinguishers on board during hours of operation: at minimum Class 2A, 10B & C rated extinguisher(s); if deep frying: a Class K extinguisher also required. *MFV* must comply with all Town fire code requirements.
- If the *MFV* operates after dark, shall provide appropriate and adequate lighting. Lighting shall be such that minimizes the glare on roadways and surrounding properties.
- No signage allowed other than signs permanently attached to *MFV* vehicle and one (1) sandwich board sign (max height 4' and 8sqft face) during operating hours only.
- Noise level from *MFV* vehicle and operations shall comply with Town noise ordinance.
- *MFV* vehicle should be a minimum of 25 feet from any permanent structures. Zoning Administrator may, upon recommendation of the Fire Marshal, approve location within 25 feet or less based upon building type, building materials, existing fire breaks and other relevant information.
